

This yields the total number of full-time equivalent jobs (FTE) funded by the Recovery Act during the reporting quarter, but does not reflect jobs created/retained in previous quarters (or the lack thereof). ARRA VOCA funding has been of great value to providers of direct services to crime victims in the State of Alabama. The funding has provided for the creation or retention of the following types of jobs: victims advocates, court advocates, crisis line workers, Sexual Assault Nurse Examiners, domestic violence shelter managers, night and relief workers for shelter programs, child advocates, forensic interviewers, counselors, etc. ARRA VOCA subgrantees have expressed great appreciation for their Recovery Act funding and state that it has provided positive results within their communities. Additionally, the administrative funds of the ARRA VOCA funds have paid a portion of program management and program integrity monitoring salaries. The State of Alabama has awarded all of its ARRA VOCA funding and more than 50% of the federal award has been drawn down.
